Contributions are not deductible for federal income tax purposes. Federal Election Law requires us to report the name, address, occupation, and employer for contributions that aggregate in excess of \$200 in an election cycle. The maximum an individual may contribute is \$2,700 per election. A couple may contribute \$5,400, designated per person in accordance with the proceeding sentence. Federal multi-candidate PACs may contribute \$5,000 for the primary and \$5,000 for the general election. Contributions from corporations, labor organizations, federal government contractors, and foreign nationals without permanent residency status ("green cards") are prohibited.
