John Faso Victory Committee

The JFC is a joint fundraising committee composed of Faso for Congress ("Campaign"), Empire State PAC ("LPAC") and NRCC (each, a "Committee," and, collectively, the "Committees").

Any contribution to the JFC permissible under the Federal Election Campaign Act, as amended ("FECA"), 52 U.S.C. §§ 30101 *et seq.*, from contributors who have not exceeded their applicable Federal contribution limits, shall be allocated among the Committees pursuant to FECA and the formula set forth in this Notice.

Contributions Made by an Individual or Federal Non-Multicandidate Political Committee:

The maximum possible yearly contribution that an individual or federal non-multicandidate political committee may make to the JFC is \$247,400. Contributions to the JFC from individual or federal non-multicandidate political committees shall be disbursed as follows:

- a. From the first \$5,400, Faso for Congress shall receive any contribution to the JFC, for deposit in its general account and designated for the primary election, in an amount not to exceed \$2,700 and designation for the general election, in an amount not to exceed \$2,700.
- b. From the next \$10,000, NY Republican Federal Campaign Committee shall receive, for deposit in its federal account not exceeding \$10,000 per calendar year.
- c. From the next \$5,000, Empire State PAC shall receive, for deposit in its federal account, any contribution to the JFC not exceeding \$5,000 per calendar year.
- d. From the next \$33,900, the NRCC General Account shall receive any contribution to the JFC not exceeding \$33,900 per calendar year.
- e. From the next \$101,700, the NRCC Building Fund shall receive any contribution to the JFC not exceeding \$101,700 per calendar year.
- f. From the next \$101,700, the NRCC Legal Proceedings Fund shall receive any contribution to the JFC not exceeding \$101,700 per calendar year.

Contributions Made by a Federal Multicandidate Political Committee:

The maximum possible yearly contribution that a federal multicandidate political committee may make to the JFC is \$120,000. Contributions to the JFC from federal multicandidate political committees shall be disbursed as follows:

- a. From the first \$10,000, J o h n Faso for Congress shall receive any contribution to the JFC, for deposit in its general account and designated for the primary election, in an amount not to exceed \$5,000 and designated for the general election, in an amount not to exceed \$5,000.
- b. From the next \$5,000, Empire State PAC shall receive, for deposit in its federal account, any contribution to the JFC not exceeding \$5,000 per calendar year.
- c. From the next \$15,000, the NRCC General Account shall receive any contribution to the JFC not exceeding \$15,000 per calendar year.
- d. From the next \$45,000, the NRCC Building Fund shall receive any contribution to the JFC not exceeding \$45,000 per calendar year.
- e. From the next \$45,000, the NRCC Legal Proceedings Fund shall receive any contribution to the JFC not exceeding \$45,000 per calendar year.

The contributor's signature below shall serve as written designation of his or her contribution to the particular elections described above.

All contributions permissible under FECA, but which would cause a contributor to exceed any applicable Federal contribution limit to a specific Committee, shall be reallocated to the remaining Committees according to this allocation formula to the extent permitted by FECA. Any contribution that would otherwise cause a contributor to exceed any applicable Federal contribution limit or that is otherwise impermissible under FECA shall be refunded to the contributor. Any contributor may designate his or her contribution to specific participating Committee, to the extent permissible by FECA. Any contributor may make his or her contribution payable directly to any of the participating Committee(s) listed in the Preamble to this Notice. Any such designated contribution that causes the contributor to exceed the contribution limit to the designated Committee shall not be reallocated by the JFC absent the prior written permission of the contributor as required by law.

Contributions to the JFC, or any of the participating committees individually, are not deductible as charitable donations for Federal income tax purposes. All funds received in response to this solicitation will be subject to federal contribution limits and prohibitions. Contributions from corporations, national banks, labor unions, foreign nationals without "green cards," and federal government contractors are prohibited. No contributions to the NRCC Legal Proceedings Fund or the NRCC Building Fund will be used to influence any federal election.

The maximum amount an individual or a federal non-multicandidate political committee may contribute to JFC is \$247,700. The maximum amount a federal multicandidate political committee may contribute to JFC is \$120,000.

Federal law requires us to use our best efforts to collect and report the name, mailing address, occupation, and name of employer of each individual whose aggregate contribution exceed \$200 in an election cycle or calendar year, as applicable.
